Scoring Criteria

Each component of the scorecard is given weightage score that are added to calculate the total facility score. A facility needs to achieve 80% weighted score to qualify for readiness.

**HF readiness- 20%,
IPC- 10%,
Equipment and materials- 15%,
HR 25%,
Essential Supplies- 15%,
Medicines 15%,**

the analysis will be based on the weighted score having a cumulative score of 80% or more to qualify.
